2. Price for items must include VAT.
3. Price for items must be firm.
4. Proposal must be valid for a minimum period of 90 days.
5. Delivery period must be indicated and firm.
6. Proposals must be signed by a duly authorized person. No faxed tenders will be accepted.
7. An original tax clearance certificate must be attached. No proposal will, however be awarded to bidders who have failed to submit the original tax clearance certificate.
8. The 80/20 evaluation system will be applicable, where 80 points, will be allocated for PRICE and where 20 points, will be allocated for B-BBEE Status Level Verification Certificate, OR the 90/10 evaluation system will be applicable, where 90 points, will be allocated for PRICE and where 10 points, will be allocated for B-BBEE Status Level Verification Certificate.
