 - Personal details of the owners are correct and accurate
 - Indigent Status of the household

Only bidders who meet minimum requirements and obtain functionality score of 70% or more will be considered.

NB: Successful bidder must employ or utilise Local Unemployed Youth for the above mentioned work.

Minimum Requirements

Valid tax clearance certificate must be attached. (Pin Confirmation Letter)

In case of the Joint Venture valid and original valid tax clearance certificates of all parties must be attached.

Certified Copy of Company Registration reflecting names and identity numbers of active shareholding must be attached.

In case of a JV Certified Copy of Company Registration Certificate reflecting names and identity numbers of active shareholding of all 4. parties must be attached

Copy of JV agreement (in case of JV) must be attached.

- Municipal Rates and Taxes Clearance Certificate/ Account not older than 90 days or a lease agreement must be attached. Failure to submit Municipal Rates and Taxes Clearance Certificate/ Account or lease agreement will be disqualification.
- In case of a JV Municipal Rates and Taxes Clearance Certificate not older than 90 days or a lease agreement of all parties must be attached.

No bid will be considered from the persons in the Service/Employment of the State/Government

- Bidder/s who fails to submit an original or certified copy of a B-BBEE Certificate will forfeit B-BBEE points
- The service must be registered on the Central Supplier Database of the National Treasury. Failure to submit CSD Registration Documentation will lead to disqualification.
- The bids will be evaluated in terms of 80/20 Preference Point System as Prescribed in the Preferential Regulations of 2017.

The successful service provider will be the one who scores the highest points

Bids must be valid for a minimum period of 90 days

Completed bid must be deposited in the tender box at Municipal Offices, 38 Joubert Street, Ladybrand, 9745, not later than the closing date and time
