All bids must comply with the following conditions:

- Price for items must be firm.
- Proposals must be **valid for a minimum period of 90 days.**
- Service period must be indicated and firm.

- An original tax clearance certificate must be attached.** No bid will, however be awarded to bidders who have failed to submit the original tax clearance certificate.
