**All bids must comply with the following conditions:**

2. Price for items must be firm.

5. Bids must be signed by a duly authorized person. No faxed bid will be accepted.
6. **An original tax clearance certificate must be attached.** No bid will, however be awarded to bidders who have failed to submit the original tax clearance certificate.
