GENERAL CONDITIONS

All bids must comply with the following conditions:

1. Item must be fully described.
2. Price for items must include VAT.
3. Price for items must be firm.
4. Bid must be **valid for a minimum period of 90 days.**
5. Delivery period must be indicated and firm.
6. Tender must be signed by a duly authorized person. No faxed tenders will be accepted.
7. **An original tax clearance certificate must be attached.** No tender will, however be awarded to tenderers who have failed to submit the original tax clearance certificate.
8. The **80/20** evaluation system will be applicable, where **80 points**, will be allocated for PRICE and where **20 points**, will be allocated for **BBBEE Status Level Verification Certificate.**
9. The **90/10** evaluation system will be applicable, where 90 points, will be allocated for PRICE and where 10 points, will be allocated for **BBBEE Status Level Verification Certificate.**
