All bids must comply with the following conditions:

- Item must be fully described.
- Price for items must include VAT.
- Price for items must be firm.
- Bid must be valid for a minimum period of 90 days.
- Delivery period must be indicated and firm.
- Bid must be signed by a duly authorized person. No faxed tenders will be accepted.
- An original tax clearance certificate must be attached.** No bid will be awarded to bidders who have failed to submit the original tax clearance certificate.
- The 80/20 evaluation system will be applicable, where 80 points, will be allocated for PRICE and where 20 points, will be allocated for B-BBEE Status Level Verification Certificate, OR the 90/10 evaluation system will be applicable, where 90 points, will be allocated for PRICE and where 10 points, will be allocated for B-BBEE Status Level Verification Certificate.
- Bidders are required to, together with their proposals, submit original and valid B-BBEE Status Level Verification Certificate or certified copy thereof to substantiate their B-BBEE rating claims with SANAS logo, for Exempted Micro Enterprise (EME) must submit certificate issued by Registered Auditors and Accountants with Practice Number
