- 9. Bidder/s who fails to submit an original or certified copy of a B-BBEE Certificate will forfeit B-BBEE points (If tendered is a JV, a consolidated B-BBEE certificate is required).
- 10. The service must be registered on the Central Supplier Database of the National Treasury. Failure to submit CSD Registration Documentation will lead to disqualification.
- 11. The successful service provider will be the one who scores the highest points
- 12. Three sets of Audited Annual Financial Statements must be attached on the bid document
- 13. Bids are valid for a minimum period of 90 days

Tenderers should have specific experience of the work for which a bid is submitted with a CIDB grading of <u>5 CE PE/ 6 CE</u> or higher for the appropriate tenders.
