- Proof of fidelity cover/insurance;
- Must be registered in terms of the Financial Services Board (proof thereof must be provided);
- Latest credit rating report prepared by an independent credit rating agency;
- Valid-original tax clearance certificate or Tax Compliance Status Pin (TCS)
- Original or certified B-BBEE certificates must be attached to claim preference points.
- Certified copy of company registration certificate reflecting name and identity numbers of active shareholding of all parties
- Municipal Rates & Taxes Clearances Certificate not older than 90 days or Lease agreement
- No bid will be accepted from a person who is in the service of state
- MBD 4 Declaration of interest must be completed and signed
- No faxed or e-mailed bids will be accepted
- Bids received after closing TIME and/or DATE will not be considered
