- Certified Copy of Company Registration reflecting names and identity numbers of active shareholding must be attached.
- In case of a JV Certified Copy of Company Registration Certificate reflecting names and identity numbers of active shareholding of all parties must be attached
- Copy of JV agreement (in case of JV) must be attached.
- Municipal Rates and Taxes Clearance Certificate/ Account not older than 90 days or a lease agreement must be attached. Failure to submit Municipal Rates and Taxes Clearance Certificate/ Account or lease agreement will be disqualification. The Lease agreement must be accompanied by the Landlord account for municipal rates and taxes.
- In case of a JV Municipal Rates and Taxes Clearance Certificate not older than 90 days or a lease agreement of all parties must be attached.
- No bid will be considered from the persons in the Service/Employment of the State/Government
- Bidder/s who fails to submit an original or certified copy of a B-BBEE Certificate will forfeit B-BBEE points
- The service must be registered on the Central Supplier Database of the National Treasury. Failure to submit CSD Registration Documentation will lead to disqualification.
- The successful service providers will be those who scores the highest points
- Bid must be valid for a minimum period of 90 days
