- In case of a JV Certified Copy of Company Registration Certificate reflecting names and identity numbers of active shareholding of all parties must be attached
- Copy of JV agreement (in case of JV) must be attached.
- Municipal Rates and Taxes Account not older than 90 days or a lease agreement must be attached. Failure to submit Municipal Rates and Taxes Account or lease agreement will be disqualification. The lease agreement must be accompanied by Landlord municipal rates and taxes account.
- In case of a JV Municipal Rates and Taxes Account not older than 90 days or a lease agreement of all parties must be attached.
- No bid will be considered from the persons in the Service/Employment of the State/Government
- Bidder/s who fails to submit an original or certified copy of a B-BBEE Certificate will forfeit B-BBEE points
- The service must be registered on the Central Supplier Database of the National Treasury. Failure to submit CSD Registration Documentation will lead to disqualification.
- The successful service providers will be those who scores the highest points.
- The proof of purchase or receipt for bid document must be attached on the bid documents.
- Bid must be valid for a minimum period of 90 days.
