- Company Registration certificate reflecting names and identity numbers of active shareholding members.
- In case of JV, each JV companies must attach its Company Registration Certificate reflecting names and identity numbers of active shareholders.
- Copy of JV agreement (in case of JV).
- Municipal Rates and Taxes Account not older than 90 days or a lease agreement accompanied by landlord's municipal account must be attached. Failure to submit will be disqualification. The municipal rates and taxes must not be in arrears for more than 90 days.
- In case of a JV Municipal Rates and Taxes Account not older than 90 days or a lease agreement accompanied by landlord's municipal account must be attached for all parties must be attached. The municipal rates and taxes must not be in arrears more than 90 days.
- No bid will be considered from the persons in the Service/Employment of the State/Government/State Owned Entities.
- No bid will be considered from the persons in the Service/Employment of the State/Government
- Bidder/s who fails to submit an original affidavit or certified copy of a B-BBEE Certificate level 1 will be disqualified.
- The successful service provider will be the one who scores the highest points
